Each minute an industrial plant remains out of production costs that company tens of thousands of dollars in lost revenues. Unscheduled downtime also puts extra pressure on profit margins and endangers order fulfillment, straining customer relationships. Traditional means of conducting operator rounds, safety inspections and risk assessments have proven to be slow and tedious. OPERATOR ROUNDS AND INSPECTIONS

Many plants still find themselves stuck in the break-fix cycle. They react to issues after they happen instead of proactively conducting preventative maintenance work to forestall failures. This puts them at much greater risk for unplanned downtime and production stops. Traditional operator rounds and inspections are time-consuming, laborious and error-prone. Even when potential issues are found, the inspection results too often reach decision makers too late for preventative action.

REGULATORY COMPLIANCE

Federal, state and local agencies are taking a fresh look at environmental, health and safety (EHS) regulations. There is now a greater emphasis in every jurisdiction on ensuring workers are protected on the job and that industrial plants don't have a negative impact on their neighboring communities. Industrial facilities using traditional static data collection methods often fail to collect all necessary EHS compliance information. This information is also tedious to enter into a back-office system of record (SAP), meaning it frequently takes more time for data to reach compliance managers, preventing remedial action. This added delay exposes the plant to greater risks

for incidents and to potential regulatory fines, sanctions and/or lawsuits.
